#### 2023-2024-63 Items for Consideration

a) To receive an update from the Road Safety Working Group -Cllr Bostock Cllr S Bostock reported that there was an issue with flooding in the school. It has been reported to the county councillor and HertsCC Highways, but to date no action has been taken. The Clerk was asked to follow this up.

Members were shown images and possible locations for speed indicator signs (SID).

Cllr S Bostock was thanked for his report.

b) Walter Wallinger Fund update-Cllr Blake.
Cllr H Blake reported that there had been one award made for £450 towards a laptop required for a university degree course. Cllr H Blake added that the trustees had agreed to increase the level of award from £300 to £450 due to inflation etc.
Cllr H Blake was thanked for her report.

c) To receive an update from the Panshanger Liaison meeting update-Cllr Rochford

Cllr P Rochford reported that the entrance to the former airfield site from Panshanger Lane will be an exit only.

#### 2023-2024-54 Planning

a) 3/23/1877/HH -- 16 Chapel Lane Letty Green -- Proposal: Demolition of conservatory and two storey side extension. Erection of single storey rear extension including six roof light windows. Alterations to fenestration and creation of new front entrance.

Resolved - No objection.

b) 3/23/1874/HH -- 25 Chapel Lane Letty Green -- Proposal: Demolition of existing two storey side extension, conservatory, single storey side extension, porch to front elevation and flat roof detached garage. Construction of a two-storey rear extension, single storey front extension and alterations to fenestration to include the insertion of 1 first floor window, 2 ground floor windows and side door in existing west side elevation, additional ground floor and 1st floor windows to the existing east elevation.

Resolved - No objection.

c) 3/23/1918/FUL-- Stelfox House 7 Chapel Lane Letty Green -- Proposal: 25 metre x 45 metre private use equestrian menage arena.

Resolved – No objection but concerns were raised regarding possible traffic issues if the stables were hired out and the fact that there seems to be no mention of where the rainwater will drain to.

- d) 3/23/2074/HH -- 48 Chapel Lane Letty Green -- Proposal: Two storey rear extension. Insert 1 new first floor side window, 1 new side door and replace a ground floor rear window with bi-fold doors.

- e) 3/23/2052/FUL -- Orchard Cottage Pipers End Hertford -- Proposal: Demolition of the existing dwelling and its replacement in a different location on the same plot.

Resolved - No objection, in fact the developer is to be congratulated on the eco friendly design of this property.
